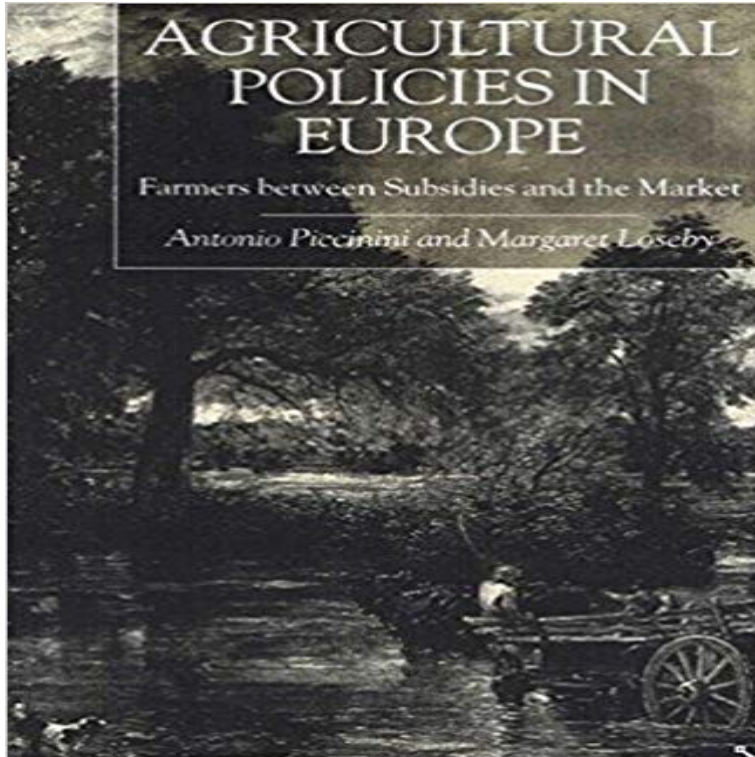


# Agricultural Policies in Europe and the USA: Farmers Between Subsidies and the Market
