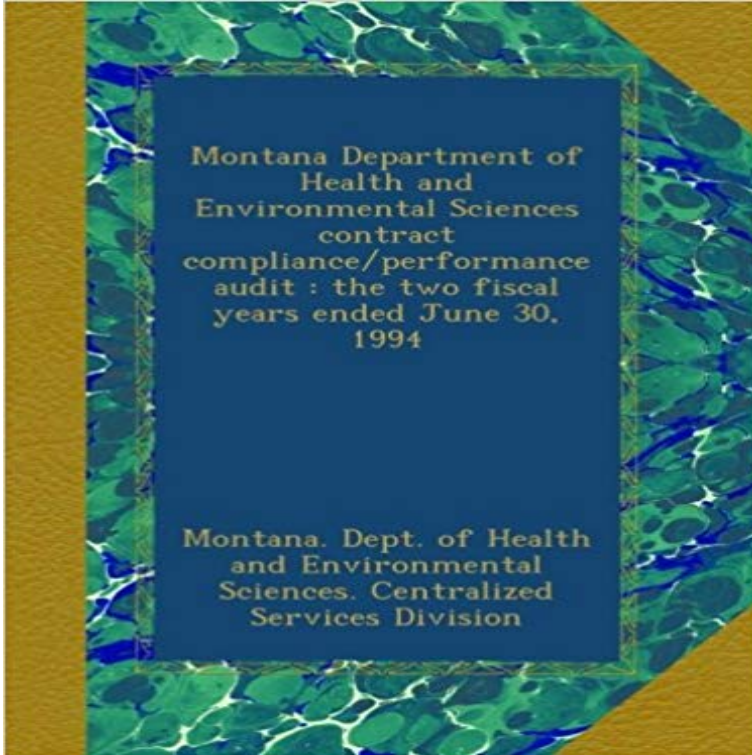


Montana Department of Health and Environmental Sciences contract compliance/performance audit : the two fiscal years ended June 30, 1994
